BYLAW 2017-002

Being a Bylaw of Vulcan County in the Province of Alberta to provide for a Pre-Authorized Tax Installment Payment Plan.

WHEREAS pursuant to the authority conferred on Council by Sections 340 of the Municipal Government Act, being Chapter M-26.1 of the Revised Statutes of Alberta, 2000, and amendments thereto, whereby a Council, by bylaw, may provide for the payment of taxes by installments;

NOW THEREFORE the Council of Vulcan County, in the Province of Alberta, duly assembled enacts as follows:

1. Definitions

- a) "County" means Vulcan County.
- b) "Plan" means Pre-Authorized Tax Installment Payment Plan.
- c) "Taxes" means all taxes levied by the County and without in any way restricting the generality of the foregoing, shall include property taxes, frontage taxes and local improvement taxes.
- d) "Taxpayer" means a person liable to pay taxes to the County.
- A taxpayer may elect to pay their property taxes in monthly installments by pre-authorized transfer of funds from their bank account, rather than one single tax payment. An application for Pre-Authorized Tax Payment Plan is attached to this Bylaw as Schedule "A".
- 3. The Plan shall include monthly installments and shall not be subject to any tax penalties or discounts except as otherwise stated in this Bylaw. The monthly installments will be accepted by way of electronic funds transfer only.
- 4. All previous years' taxes and penalties, if any, shall be paid in full prior to entering into the Plan.

- 5. The taxpayer may enter into the Plan prior to July 1st for payment of the current years' tax levy.
- 6. Application made after July 1st, will be for the following tax year and monthly installments will begin the following January.
- 7. Monthly installments will be calculated as follows:
 - If the current year's Tax Notices have not been mailed at the time of application, the monthly installment amount will be calculated by dividing the previous years' tax levy by the remaining months in the calendar year;
 - ii) After the Tax Notices have been mailed, the remaining monthly installment amounts shall be calculated by taking the actual current years' tax levy, subtracting the prior monthly installments that have been received to date (if any), and dividing by the remaining months in the calendar year.
- 8. If a monthly installment payment is defaulted by the Taxpayer, the Taxpayer will be responsible for making alternate payment arrangements on the defaulted payment; including any fees or administrative charges in accordance with the current Fees for Services Bylaw.
- 9. If two (2) monthly installment payments are defaulted by the Taxpayer within any six (6) month period, the County shall cancel the Plan and all taxes shall become due and payable in accordance with the County's Tax Penalties Bylaw.
- 10. Taxpayers may cancel the Plan at any time upon fifteen (15) days written notice. All taxes shall then become due and payable in accordance with the County's Tax Penalties Bylaw.
- 11. It is the taxpayer's responsibility to notify the County, in writing, if they sell the property, change banks or bank accounts, or make any other changes that would affect the Plan.

Bylaw 2016-020 is hereby rescinded.

This Bylaw shall take effect on the date of the third and final reading.
