



## **VULCAN COUNTY** **Private Land** **Spraying Policy**

Vulcan County Agricultural Services will provide specialized weed control on a small acreage basis to landowners within the Vulcan County boundaries.

### Procedures:

1. At the landowners request, Vulcan County Agricultural Services will apply industrial strength herbicides to control small infestations of restricted and certain designated noxious weed infestations on their lands, at the discretion of the Manager, Agricultural Services. . Weed infestations to be sprayed by Agricultural Services will not exceed five (5) acres.
2. All landowners will sign a hold harmless agreement, a copy of which is attached to this policy, with Vulcan County Agricultural Services and will be given a copy of the pesticide label explaining residual activity of the herbicide and suggested cropping rotations.
3. Costs incurred to the landowner for this service are listed in Schedule "A" of Bylaw 2004-015.
4. Spraying will only be completed by an Agricultural Services employee who holds a valid pesticide certificate.

And I release Vulcan County, its Councillors, officers, employees, agents and representatives (the "Releasees") from any and all liability for any loss, damage, injury or expense that I may suffer or that my successors or assigns may suffer as a result of anything done that may be related to the spraying of the chemical on my land, due to any cause whatsoever, including negligence on the part of the Releasees.
