BYLAW 2024-006

Being a Special Tax Bylaw to authorize and establish the tax rates to be levied against assessable property within the fire protection areas in Vulcan County for the 2024 taxation year.

WHEREAS the estimated Special Tax levies to be raised by Vulcan County for the purposes of a fire protection area tax for each fire protection area are:

Carmangay and District Fire Protection Area	\$ 93,334
Champion and District Fire Protection Area	\$ 99,875
Lomond and District Fire Protection Area	\$ 73,562
Milo and District Fire Protection Area	\$ 133,769
Vulcan and District Fire Protection Area	\$ 75,252
Northwest Fire Protection Area	\$ 132,775

WHEREAS an averaged uniform tax rate will be levied upon the assessed value of linear property as shown on the assessment roll of Vulcan County for a Special Fire Protection Tax estimated at \$396,924.

NOW THEREFORE under the authority of Section 382 of the *Municipal Government Act*, Chapter M26, Revised Statutes of Alberta, 2000, and amendments thereto, the Council of Vulcan County duly assembled in the Province of Alberta, enacts as follows:

- 1. That the Chief Administrative Officer for Vulcan County is hereby authorized and directed to levy the following rates of taxation, as established in this Bylaw, on the assessed value of the property in each fire protection area as shown on the assessment roll of Vulcan County.
- 2. The fire protection areas subject to the special tax are outlined in Schedule "A" attached.

3. For the 2024 year there shall be levied against all assessable properties within <u>Carmangay Fire District</u> the following tax rate to generate the required sums, in accordance with the approved budget:
