### **BYLAW 2024-008**

Being a Special Tax Bylaw to authorize and establish the tax rates to be levied against parcels of land within the waterworks areas in Vulcan County for the 2024 taxation year.

**WHEREAS** the estimated Special Tax levies to be raised by Vulcan County for the purposes of a waterworks services tax for each waterworks area are:

Mossleigh Water Treatment Plant	\$ 11,425
Kirkcaldy Water Line	\$ 5,113

**NOW THEREFORE** under the authority of Section 382 of the *Municipal Government Act*, Chapter M26, Revised Statutes of Alberta, 2000, and amendments thereto, the Council of Vulcan County duly assembled in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer for Vulcan County is hereby authorized and directed to levy the following rates of taxation, as established in this Bylaw, on the parcels of land that are connected to the Mossleigh Water Treatment Plant or the Kirkcaldy Water Line in Vulcan County, or have received curbside service.
2. For the 2024 year there shall be levied against all parcels of land that are connected to the Mossleigh Water Treatment Plant or the Kirkcaldy Water Line, or that have received curbside service the following tax rate to generate the required sums, in accordance with the approved budget.
3. The properties serviced by the system and subject to the special tax are those listed in Schedule "A" attached.

4. The combined estimated cost of the service at the Mossleigh Water Treatment Plant is \$11,425 for the 2024 taxation year.

5. The combined estimated cost of the service from the Kirkcaldy Water Line is \$5,113 for the 2024 taxation year.

This Bylaw shall take effect on the date of the third and final reading.

READ a second time on this 1<sup>st</sup> day of May, 2024.

READ a third time on this 1<sup>st</sup> day of May, 2024.
