PURSUANT to section 606 and 692 of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, as amended, the Council of Vulcan County in the Province of Alberta hereby gives notice of its intention to adopt proposed Bylaw No. 2024-024 being a bylaw to amend Land Use Bylaw No. 2020-028.

**The purpose of proposed Bylaw No. 2024-024 is to redesignate Plan 9913008, Block 1, containing approximately 5.31 ha (13.13 acres) as shown on Schedule 'A', from "Rural General - RG" to "Rural Recreational - RR". The purpose of the proposed amendment is to provide for the opportunity to develop the parcel in accordance with the provisions of the Rural Recreational Land Use District.**

**Therefore, take notice that a public hearing to consider proposed Bylaw No. 2024-024 will be held in the Vulcan County Council Chambers at 11:05 a.m. on February 5<sup>th</sup>, 2025.**
