# **Rules & Regulations**

Vulcan County invites you to participate in our 2025 Photo Contest. We want your help capturing the many great qualities of living in Vulcan County. Topics can include but are not limited to agriculture, recreation, local business, tourism etc.

Please carefully read through the rules & regulations below before submitting your photos.

#### About:

# The contest runs from Tuesday, August 5, 2025, at 12:00 a.m. MST to Tuesday, September 30, 2025, at 11:59 p.m. MST.

- It is open to all ages; however, all photo release forms must be signed by a legal guardian or parent for those under the age of 18.
- Three winners will be chosen by our panel of judges. The grand prize winner will receive a gift value of \$200, second place will receive a gift value of \$100 and third place will receive a gift value of \$75.
- All photos need to be taken within Vulcan County, with the location noted on the entry form.
- All photos may be published on the Vulcan County website, social media and potentially on future print materials. Photographer credit will accompany each photo.
- County councillors, employees and their immediate families are welcome to submit photos; however, they will be ineligible to win a prize.

## **Photo Requirements:**

- Each individual may enter up to 5 photos.
- Entry must include a completed entry / photo release form and digital file of the photo(s) in a jpg format
- Photos must be original, high resolution, landscape, JPG file of at least 300dpi (3600 x 2700)
- We will not accept photos that have been heavily retouched, altered, cropped, or with watermark overlays.
- Any entries missing a photo release form, or whose photos to not fit the above guidelines will not be accepted.
- Photos may include identifiable faces if consent has been given to the photographer. See further details in the Photo Release Form.

#### **How to Submit:**

- 1. Download and review the "Rules & Regulations / Photo Release" document.
- 2. Click on the link to submit your entry form.
- 3. Attach your photos to an email with the subject line "Photo Contest Your Name" and send to photos@vulcancounty.ab.ca

#### Disclaimer:

By submitting your photo(s) you hereby consent to the publication of photographs or other images submitted in connection with the Photo Contest. The image(s) may be used in its original form or in any edited form without prior approval of the entrant.

#### Prize:

- 1. The winner will be announced and contacted the week of October 6th, 2025.
- 2. If the entrant is under the age of 18 a legal guardian will need to be present to collect the prize.
- 3. Prizes must be picked up at the Vulcan County Administration Building located at 102 Centre Street, Vulcan AB. If the winner does not claim the prize within 10 days of being contacted the winner will be deemed to irrevocably forfeit the prize and a new winner may be chosen.
- 4. The prize must be accepted as awarded, without substitutions and cannot be converted to cash.
